### **Privacy Policy**

This document sets out our privacy policy, which has been drawn up in line with best practice issued by the Information Commissioner's Office (ICO). It is fully supported by management and has been agreed with our team. Thank you for reading it. We very much welcome suggestions for improvement; our contact details are below.

### About Digital Remit

Digital Remit Limited is a Data Processor <u>and</u> a Data Controller. We are registered with the Information Commissioner's Office under number ZA051855. Our Data Protection Officer is Justin Jackson. You can find all relevant contact details at the end of this policy.

### Our role as a Data Controller

The remainder of this document concerns our role as a Data Controller.

We process your personal data because this is necessary to keep you informed about the services we offer and to ensure that our communication with you is tailored to your interests and requirements. There is no need for us to process sensitive personal data and, consequently, we do not do so.

In some cases, we have your consent for such processing. You have the right to withdraw this consent at any time; please contact Justin to exercise these rights.

In some cases, we have a legitimate interest in processing your data; for instance, you might be a client or have attended one of our events. Following an assessment, we have concluded that your rights do not override these interests. This is because you would reasonably expect us to process your data in this way and the impact on your privacy is minimal.

You nonetheless still have the right to demand that we no longer process your data, even where we have a legitimate interest to do so; please contact Justin to exercise these rights.

We retain your data for as long as we believe you may wish to hear from us or, of course, until you object to our processing your data.

We may rely on automated decision making. We may also use data that is obtained from third parties. This is to ensure that we create the most value for you in our communications. For instance, we may take into account your presence or activity on social networks.

We do not transfer your data to third parties, except where they provide applications or storage that help us process it. No individuals access your data outside of Digital Remit.

In some cases, your data is stored or processed outside of the European Union, but we believe that such transfers are in accordance with Chapter V of the General Data Protection Regulation.
